

CAYTON PARISH COUNCIL

Table of fees, payments and sums fixed and settled under Local Government Act 1972 and the Local Authorities Cemeteries Order 1977 approved by resolution of Cayton Parish Council, as burial authority, on **Wednesday 13th May 2026**. The charges to apply from 1st April 2027.

The fees, payments and sums set out below apply where a person to be interred, is or immediately before his/her death was, an inhabitant or parishioner of the Parish of Cayton, or in the case of a stillborn child, where the parents (or one of them) are, or at the time of interment were such inhabitants or parishioners. **In all other cases the fees, payments and sums will be doubled.** All fees are exempt from VAT.

INTERMENTS The fees indicated do not include the digging of the grave.

Notice of interment is to be given to the clerk 01723 586869 or email clerk@caytonparishcouncil.gov.uk at least 48 hours (exclusive of weekends) previous to any interment. The notice should contain the full Christian name, surname, address & age of the person to be buried, the date & place of death, the day & hour of intended burial & the number of the grave.

No interment can take place without a correctly completed Notice of Interment & Disposal Certificate having been received at least 24 hours prior to the day of interment.

Monuments, Gravestones, Tablets & Monumental Inscriptions

The permission of the Council is required before any memorial may be erected, renovated or removed, permission is also necessary for additional inscriptions to be inscribed. Permission may be sought by writing to the Council giving details of the grave number, details of the proposed work and when the work will be undertaken. **No work can be carried out until permission has been granted.**

For safety purposes we only allow memorial work to be carried out by Monumental Masons who are included in the North Yorkshire Council Register of Monumental Masons and applicants must have public liability insurance and agree, among other things, to adhere to the Code of Working Practice as issued by the National Association of Monumental Masons and abide by all Council regulations.

Exclusive Right of Burial (EROB)

An Exclusive Right of Burial grants the named owner the sole authority to permit burials and memorials in a specific grave for the duration of the lease (fifty years). The right does not give ownership of the land, which remains the property of the Council. The EROB may be transferred only with the Council's written approval. When the lease expires, it may be renewed subject to current regulations. No burial or memorial work may take place without the written consent of the EROB owner or their lawful successor.
